Prizes

1. **Student Winners - Three student winners** will be selected to receive cash prizes of **RM 300 each.**
2. **School Winner-** The school with a winning student will receive **RM 200** to create or upgrade their IRC Corner, providing more books for students.

All participating students and their teachers will receive an e-Certificate.
